Note:

If any NOC has more athletes/pairs qualified in any event than its entitled number of Quota Places, according to the BWF World Ranking Lists as of 28 March 2019, that NOC can decide to decline a Quota Place allocated to a higher ranked athlete/pair and choose a lower ranked eligible athlete/pair.

The NOC will however not be able to enter a declined athlete/pair at the time of final entries, should the lower ranked athlete/pair become unavailable.

C. Eligibility

Athlete Eligibility
<p>All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors). Only those athletes who have complied with the Olympic Charter may participate at MINSK 2019.</p>
<p>Age Requirements</p> <p>There are no age requirements for athletes competing in Badminton at MINSK 2019.</p>
<p>Medical and Anti-Doping Requirements</p> <p>To be eligible to participate at MINSK 2019, all athletes must satisfy the medical requirements according to the EOC Medical and Anti-Doping Guidelines.</p> <p>To be eligible to participate at MINSK 2019, all athletes must comply with doping control process in accordance with the EOC Medical and Anti-Doping Guidelines and the EOC Anti-Doping Rules.</p>
<p>Additional Badminton Europe Confederation (BEC) Requirements</p> <p>To be eligible to participate at MINSK 2019, all athletes must have played in a minimum of three (3) tournaments, counting towards the BWF World Ranking Lists during the Qualification period, and be registered in the BWF World Ranking Lists of 28 March 2019.</p>



D. Qualification Process

The qualification system allows for the participation of the best athletes through a fair and transparent process within the framework of the Olympic Charter.

The BWF World Ranking Lists of 28 March 2019 will be used to allocate the athletes Quota Places in Men’s and Women’s Singles, Men’s and Women’s and Mixed Doubles.

Each list will be based on results achieved during the period from 26 March 2018 to 24 March 2019. The BWF World Ranking Lists of 28 March 2019 shall be changed into the European Ranking Lists by removing all players, who are not qualified to represent any NOC in accordance with EOC regulations, and this European Ranking list shall be used to allocate places.

Only pairs with athletes from the same NOC will be considered during the quota allocation in doubles and mixed events.

Host NOC Allocation

Allocation Process
<p>The Host NOC is guaranteed the following allocation subject to meeting the eligibility requirements detailed in Section C.</p> <p>The Host NOC is entitled to two (2) Quota Places in Women’s Singles, two (2) Quota Places in Women’s Doubles and two (2) Quota Places in Mixed Doubles should the Host NOC not qualify any quota place in each Singles and Doubles events.</p> <p>If there is no the Host NOC athlete(s) on the BWF World Ranking Lists, the NOC will choose and confirm the respective athletes to the BEC, at the latest by 14 April 2019.</p>

Universality

Allocation Numbers
<p>Four (4) Male Universality Places are made available to eligible NOCs at MINSK 2019: two (2) in Men’s Singles and two (2) in Men’s Doubles events.</p> <p>Three (3) Female Universality Places are made available to eligible NOCs at MINSK 2019: one (1) in Women’s Singles and two (2) in Women’s Doubles events.</p> <p>These places will be allocated by the EOC Technical Group in conjunction with the BEC.</p>

E. Confirmation Process for Quota Places

MEGOC on behalf of the EOC and the BEC will inform, in writing, the respective NOCs of their allocated quota places by 1 April 2019.

By 10 April 2019, eligible NOCs must inform, in writing, MEGOC whether or not they intend to use the allocated quota places and participate at MINSK 2019.

By 20 April 2019, the BEC will reallocate all unused quota places and inform, in writing, MEGOC.

F. Reallocation of Unused Quota Places

If obtained through the qualification process and allocated quota place is declined by the NOC or is not confirmed by the NOC by the deadline, the quota place in that event will be reallocated to the next best ranked player(s)/pair, not yet qualified.

This process will be repeated until all places are allocated.

Any unused Universality places will be returned to the BEC and be assigned to the respective gender, using the process in place to allocate unused NOC quota places as outlined above.

H. 2020 Summer Olympics Qualification

No direct qualification for Tokyo 2020 will be available in Badminton at MINSK 2019. All five (5) events played at MINSK 2019 shall count towards the BWF World Ranking, and thereby the qualification towards Tokyo 2020. The amount of point awarded are equivalent to the ones awarded at the Continental Championships.
