2. Entry Details

| Regulations | The Tournament will be played in accordance with the Badminton Europe regulations as laid down in App. V (European Junior Team Championships) and the Laws and Regulations as adopted by the Badminton World Federation. Regulations can be found here The European Junior Team Championships first stage will be played in groups of three, four or five teams where all teams play all other teams in the same group. The final stage will be played as a knock-out draw. |

| Eligibility | All Badminton Europe Members are eligible to compete in the event. Participants in the 2024 European Junior Team Championships shall be restricted to players born in 2006 or later. |















3. Tournament Details

| Seeding Date | The seeding will be made according to Appendix V (Regulations for the European Junior Team Championships) regulation 7. The seeding for the team event will be based on the results of the 2023 European U17 Team Championships, the 2022 European Junior Team Championships and the ranking published on 5 November 2024 . The seeding will be announced on 7 November 2024 . |

| Nomination of players | Each competing team must submit nominations of every player it intends to use in the event no later than 23 November 2024 at 23:59 CEST, using the same link as for making the team entry (see Entries). Only nominated players shall be permitted to play in the event as selected players or substitutes. No additional players can be added after the player nomination deadline. In this connection, we draw your attention to the BWF General Competition Regulations 6 on International Representation. |
| Draw Date | The draw of the group stage will be conducted and published on 8 November 2024. |

| Technical Official briefing | The Technical Official briefing will be held on 25 November 2024 – 20.30 at Hotel Royal Plaza |
| Medal ceremonies | All medals will be presented on Saturday 30 November 2024 after the final. All nominated players of the winning team, being present, shall be presented with gold medals, all nominated players of the second ranked team, being present, shall be presented with silver medals and all nominated players of the teams losing the semifinals, being present, shall be presented with bronze medals. All such medals shall be suitably inscribed. |
| | Two nominated representatives for each of the four medal winning teams shall accompany his/her team at the medal ceremony and shall receive a token from Badminton Europe for his/her team's achievement. |

| Clothing and advertising | Players need to ensure that their clothing complies with the existing BWF Regulations and § 11 and § 12 in these regulations. Failing to do so shall result in an administrative fine of 50,00 EUR for each breach. |















Colour of players' clothing;

Members need to ensure that their players' clothing complies with the existing BWF Regulations and § 16 and § 17 in these regulations. Failing to do so shall result in an administrative fine of 50,00 EUR for each breach, unless otherwise stated below.

Colour of players' clothing

In team matches players must wear team colours. That is each player must wear the same colour and design of shirts and shorts (or other equivalent articles of clothing) throughout a tie. Failing to do so shall result in an administrative fine of 250,00 EUR for each tie.

In the final stage it is mandatory that the opposing teams in each tie wear different colours from each other. A team seeded lower or not seeded will be required to wear clothing of a significant different colour. Where both teams are seeded the same or are both not seeded, the team listed lower in the draw will be required to change the colour of clothing. Failing to do so shall result in an administrative fine of 100,00 EUR for each tie.

Player names

The name of the player on the back of the shirt is optional.

Member names

The name of the player's country on the back of the shirt is mandatory.

The Referee is instructed to pay particular attention to uphold these regulations on clothing. In applying regulations on clothing and designs and advertising on players' clothing the decision of the Referee shall be final.

Advertising on players' clothing must comply with the existing BWF Regulations.

Badminton Integrity

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).

Doping control

Anti-doping testing may be carried out on a random basis at any time, as per BWF and WADA regulations.

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
